Events

Entry fee is \$10.00 per athlete. The AAU membership card is \$12.00 for youth athletes age 18 and under. Coaches, volunteer and adult AAU athlete memberships are \$14.00. The Association meet is youth only. Note: Primary, Sub Bantam, Bantam, Sub Midget, and Midget are allowed only three (3) events, including relays. Youth, Intermediate, Young Men/Women are allowed only four (4) events, including relays.

***Athletes who are eighteen (18) years of age through the final day of the National Track & Field Championships shall be Eligible to compete in the Young Men's and Young Women's Division through that meet (i.e., born in 1989 and after Aug. 2).**

READ BEFORE SIGNING: I certify that in accordance with the rules of AAU Track & Field, I am eligible to compete in the indicated sports. I acknowledge that there are certain risks inherent in athletics competition, and I freely accept those risks.
